Terms and Conditions

By agreeing to these Fleet Mortgages terms and conditions, I am confirming that:

- I take full responsibility for the accuracy of any information supplied to Fleet Mortgages and will provide answers to all relevant questions
- I am authorised by the FCA and have any permissions required in order to submit any application
- I will comply with the FCA rules in submitting any application
- I will immediately inform Fleet Mortgages Limited if my FCA authorisation is varied or withdrawn or if I or my firm is subject to FCA disciplinary action
- I have a valid professional indemnity insurance policy in place
- I have not and will not use the name of Fleet Mortgages Limited or any trading style adopted by Fleet Mortgages Limited in any Financial Promotion or other advertising of any kind without the written consent of Fleet Mortgages Limited
- I understand that Fleet Mortgages Limited cannot disclose to me any information supplied to it by any third parties (including credit reference and fraud prevention agencies)
- I accept that Fleet Mortgages may share any information provided by me, including in relation to me or my firm, with fraud prevention agencies in order to prevent fraud and money laundering and that other organisations may also have access to this information
- I confirm that I have seen the Fleet Mortgages Fair Processing Notice and I accept that the terms of the Fair Processing Notice also apply to information provided by me in relation to me and to my firm
- Fleet Mortgages Limited are under no obligation to reveal to me the reasons for any decisions taken in respect of an application
